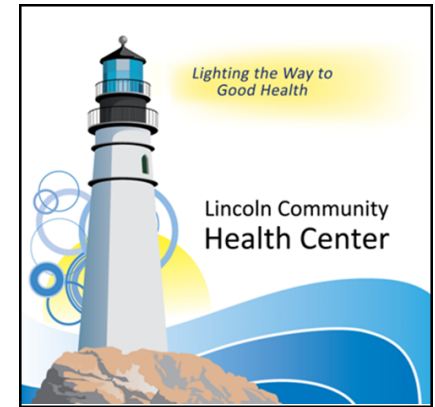

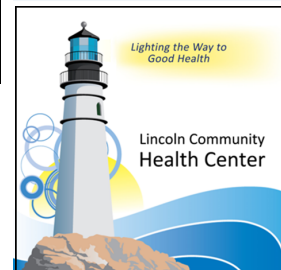

Student Privacy

All services are private & confidential. Health center records will not become part of a student's school record & information cannot be shared with school personnel without permission.



Confidentiality Notice

All services are confidential, however if we feel a student is in danger of hurting themselves or others or if harm of any kind is suspected, we are required to report this information. Animal bites & certain communicable diseases must also be reported.

Students aged 15 years and older may access all services for themselves.

Students 14 years and older may seek mental health and alcohol & drug services without parent permission.
